# DRUG-FREE ENVIRONMENT AND DRUG PREVENTION PROGRAM

The District is committed to providing its employees, students, and volunteers with a drug-free workplace and campus environment. The District emphasizes prevention and intervention through education. Student Health Services and Human Resources share the responsibility for implementing and continuously improving this procedure.

## **Prohibition of Drugs and Alcohol**


The unlawful manufacture, distribution, dispensing, possession, or use of alcohol, marijuana, or any controlled substance is prohibited on District property, during District-sponsored field trips, activities or workshops, and in any facility or vehicle operated by the District, except as permitted by AP 3560 Alcoholic Beverages and BP/AP 4300 Field Trips and Excursions.

Violation of this prohibition will result in appropriate action up to and including termination of employment, expulsion, and referral for prosecution, or, as permitted by law, may require satisfactory participation in an alcohol or drug abuse assistance or rehabilitation program.

As a condition of employment, employees must notify the District within five days of any conviction for violating a criminal drug statute while in the workplace. The District is required to inform any agencies that require this drug-free policy within ten days after receiving notice of a workplace drug conviction.

## **Student Safety**

The District shall provide, as part of established campus orientations, educational and preventive information provided by the State Department of Public Health about opioid overdose and information about the use and location of fentanyl test strips and opioid

overdose reversal medication to students at all campuses. The District will notify students of the presence and location of fentanyl test strips through a method such as email.

Each campus health center shall apply to distribute dosages of a federally approved opioid overdose reversal medication and participate in the Naloxone Distribution Project administered by the State Department of Health Care Services. Upon approval to distribute dosages of a federal approved opioid overdose reversal medication and participation in the Naloxone Distribution Project, each campus health center will distribute a federally approved opioid overdose reversal medication obtained through the Naloxone Distribution Project. Each campus health center will also stock and distribute drug testing devices and fentanyl test strips in the campus health center. The campus health center will distribute written instructions on how to properly use the fentanyl test strips together with the fentanyl test strips.

#### **Resources for Students**


Student Health Services provides confidential individual counseling for students who have questions or concerns about their use of alcohol or use of other substances. Referrals are also made to community resources such as Alcoholics Anonymous and Narcotics Anonymous.

The District has also implemented an electronic early warning system to notify Campus Security and the Behavioral Intervention Team (BIT) of a "student of concern." This system enables anyone experiencing or witnessing an interaction with a student whose conduct seems to be abnormal to inform District authorities who are specially trained to respond and intervene in a timely manner to such concerns. The individual notifying the District about the student of concern may do so without fear of retaliation by the student being reported.

## **Resources for Employees**

The District offers a fully-paid employee assistance program which is available to all employees and family members in their household.

Employees who are enrolled in District health insurance plans have access to an additional employee assistance program which provides assistance by phone 24 hours a day, seven days a week. This assistance also extends to family members living in the same household as the employee.
